# Changes to travel restrictions for immediate family members of Canadian citizens and permanent residents

The Canada Border Services Agency is announcing an easing of travel restrictions that could allow families divided by international borders during the COVID-19 pandemic response to reunite.

As of June 8, foreign nationals who are immediate family members of Canadian citizens and permanent residents, and who do not have COVID-19 or exhibit any signs or symptoms of COVID-19, or who do not have reason to believe they have COVID-19, will be exempt from the prohibition on entry to Canada if entering to be with an immediate family member for a period of at least 15 days.

Foreign nationals who are admitted into Canada pursuant to this exemption **must quarantine for 14 days**.

All foreign nationals who have COVID-19 or exhibit any signs or symptoms of COVID-19 continue to remain prohibited from entering Canada.

### **Supports for Off-Reserve Members**

We are still frequently asked what supports are available for members who live off reserve.

For those of you looking for additional supports for off reserve members, the \$350 million Emergency Community Support Fund through Employment and Social Development Canada is specifically for charities and non-profits to respond to COVID-19. The investment will flow through three national intermediaries that have the ability to get funds quickly to community organizations that serve vulnerable populations. That could include urban Indigenous and off-reserve organizations, and potentially Tribal Councils. Proposals are already being accepted and can support a variety of activities that address a pressing social inclusion or well-being need caused by COVID-19, such as:

- increasing volunteer-based home deliveries of groceries and medications
- scaling up help lines that provide information and support



- helping vulnerable Canadians access government benefits
- providing training, supplies, and other required supports to volunteers so they can continue to make their invaluable contributions to the COVID-19 response
- replacing in-person, one-on-one contact and social gatherings with virtual contact through phone calls, texts, teleconferences, or the Internet

# Order extended to enable use of technologies during COVID-19

The Province of British Columbia is extending a temporary ministerial order until Dec. 31, 2020, to continue to allow health-care workers and other public sector staff to use communication tools not normally permitted for use during the COVID-19 state of emergency.

British Columbia has the strictest privacy and dataresidency laws in Canada. It is one of two provinces with legislation requiring the personal information of its citizens to be stored in, and only accessed from, Canada. These protections also mean common communication and collaboration software tools, which are routinely allowed in other provinces and are useful in the fight against COVID-19, are not normally permitted for use by BC public-sector staff.

Renewing the ministerial order means health-care bodies like the Ministry of Health, the Ministry of Mental Health and Addictions and health authorities can continue to use software and technology that has

proven useful in their life-saving efforts to protect British Columbians from the spread of COVID-19.

The temporary measure also enables schools and post-secondary institutions to provide increased online learning opportunities for students who may be displaced or unable to attend in-person classes.

## Library renewal project for Coast Mountain College

The Province of BC has announced a \$4.4million library renewal project at Coast Mountain College (CMTN) in Terrace that will create construction-related jobs for regional businesses and tradespeople. It incorporates Indigenous design and child-friendly spaces.

"In these challenging times, our government is working to ensure that we are doing everything possible to support British Columbians in every part of the province," said Melanie Mark, BC's Minister of Advanced Education, Skills and Training.

The project design team worked with Coast Mountain's First Nations Council and sought the input of students to design space that supported the college's First Nations students in its function and reflection of local First Nations culture. The design includes an Indigenous reading circle crafted from local cedar. Work is expected to begin this summer.

# Funding available to support volunteer projects in BC Parks

BC Parks is making \$240,000 available this year for volunteer and other community-led projects that support conservation and recreation. Under the **Park Enhancement Fund**, volunteers and community groups can apply for up to \$5,000 per project for 2020-21. Each of the six BC Parks regions has been allocated \$20,000 to support conservation projects and \$20,000 to support recreation projects. In past years, funding has gone to projects that include controlling invasive species, gathering conservation data and installing interpretive signage, as well as building huts, docks and trails.

### QUESTION OF THE DAY

# What should First Nations consider when planning to resume/reopen some of its services?

Further guidance in planning and recommended safety measures is available through the First Nations Health Authority and WorkSafe BC, including a general guide on COVID-19 and returning to safe operation; frequently asked questions; occupancy limit poster; and handwashing poster. The WorkSafe BC site includes tips that may help you plan for the eventual reopening of Band Administration offices or other operations shuttered as part of your pandemic response.

Other resources are also available to help inform reopening decisions. The Canadian Water and Wastewater Association has released a **COVID-19 fact sheet on safely re-opening buildings**. You may find it relevant and helpful as you consider the reopening of Band administration buildings. It lists the steps to be taken after any period of shutdown or low occupancy. For example, it's recommended a building's water system be flushed to replace stagnant water within the system with fresher, treated water to minimize the risk of microbial growth in plumbing.

Health Canada has published a **list of hard surface disinfectants** that are likely to be effective for use against COVID-19. This list is updated regularly. Although they do not claim to kill viruses such as COVID-19, cleaners play a role in helping limit the transfer of microorganisms.
